RELEASE, WAIVER, AND INDEMNITY AGREEMENT

RULES FOR ALL ACTIVITIES (must be read before participating)

- I will sign a release and waiver prior to the day or session of activity, and I acknowledge that this agreement is binding.
- I understand the nature of this activity and that I am qualified, in good health, and in proper physical condition to participate and acknowledge that if I believe conditions are unsafe, I will immediately discontinue participating in the activity.
- I realize there is a risk and assume all responsibilities of the same.
- I will follow all special instructions (including these rules), which the facilitator, lifeguards, referees or their agents may give prior to each activity.
- I will read and obey all signs posted.
- I will treat all equipment and facilities with respect or I will pay for any damages.
- I will not use illegal drugs or alcohol of any type before or during activities.
- Should I see or believe another participant might be injured; I will immediately stop the activity and assist the participant.
- If you do not know how to swim, you must stay in waist deep water only.

PAINTBALL RULES (must be read before participating)

- I will adjust the velocity of my paint gun to shoot at or below the posted maximum (285 fps) for each game I play.
- I will wear approved goggles, and other safety equipment at all times within playing, chronograph, and target areas.
- I understand that I will be ejected from the game for the unauthorized removal of my goggles within playing, chronograph, and target areas.
- I will keep my paintball gun barrel plugged or covered at all times while outside the playing, chronograph, and target areas.
- I will do no tree climbing or other dangerous or hazardous activities while playing paintball.
- I will assist the field operator or sponsor in keeping the playing field boundaries well marked.
- I agree to all the federal, state, and local laws governing the playing of paintball.

The undersigned participant and/or legal guardian will indemnify RAINBOW CHRISTIAN CAMP, from all liability for personal injury, property damage, or wrongful death of the participant caused by any act of negligence. The undersigned participant or guardian agrees that in the event any claim for personal injury, property damage, wrongful death, or otherwise, caused by any act of negligence will indemnify and hold harmless PEARSON'S MILL CHRISTIAN ASSEMBLY, INC. d.b.a.
